Not only does CSUMB President **Peter Plympton Smith's** official record lend credence to their stays, to help accommodate the visits **Residential Life recruits** CSUMB students who stay on campus during the **summer months** of 1996 and 1997, via the school's electronic Open Forum.

Century." *The Bee* goes on to report, "The campus would be **loaded with the latest** in high-technology teaching tools and set an unconventional approach to academia." *The Bee* neither elaborates on Bill Clinton's nonconformist agenda, nor **the names or affiliations of his architects**. In 1996, *The Bee's* follow-up caption read, "**Canceled Classes, Piles of Dirt Among Challenges at Ex-Base.**" *The Bee* also fails to mention why after **students pay tuition, register, and sign a yearly lease, Smith cancels the classes**.

White House Chief of Staff Leon Panetta, and Peter P. Smith, a **Vermont politician**, inveigled academic sanction from The California State University for **the Clinton curriculum**. In a **classic bait & switch** the architects **supplant the usual, desirable, and proper course work, with courses that feel unusual, undesirable, and wrong**. Mandatory courses, such as **Service Learning**: public service to a host of thinly veiled **political action committees**. **Grant Writing**: a scam also affectionately known as **Involuntary Servitude 101**. **Vacuous courses**, such as **"Vibrancy"**. And a slew of **outcome-based flappedoodle, too preposterous, revisionist, and unintelligible** to articulate filled out the curriculum. *The Bee* omits altogether how its **Piles of Dirt** become a **mountain range of lead-laden earth and sand from a Super Fund site, which overshadows student housing like a toxic Mount Vesuvius**. *The Bee's* target readership, Sacramento, Calif., is also located two hundred miles from the Monterey Peninsula—**target enrollment of the fledgling CSU**—and both blurbs **get buried** deep within the paper to blunt possible political criticism. While students at the ex-base get treated like mushrooms: kept **in the dark**, and fed a load of horse manure.

A VOYAGE OF DISCOVERY

I TAKE UP MY PEN AND GO BACK TO THE TIME when I attend California State University – Monterey Bay. With a **mean year-round temperature fluctuation of 20**

degrees—Wednesday, 23 August 1995 dawned temperate on the Monterey Bay. Just as it had in 1542, when explorer Juan Cabrillo sailed past it. In 1846, when Commodore John Drake Sloat raised the American flag over it, and, in the 1950s when the sardine industry collapsed around it. That morning, CSU Monterey Bay's 565 pioneer students would attend classes on Fort Ord—at the Pomeroy Center, an ex-Army gymnasium on Sixth Avenue. Saturday, 12 August, to provide students with information to select a major, the pre-Registration Seminar had been held at a nearby structure. While also Army surplus, it was a somewhat more conducive venue than the gym. At the seminar, faculty from the 12 majors vied for 404 students. Of the 565 pioneers, the 161 freshmen were absent the get-together. Without lower division coursework, freshmen would be ineligible to choose their main field of study.

As early as 1991, Congressman Leon Panetta (D-CA 17th District: Santa Cruz, Monterey, and San Benito Counties) envisioned a university at Fort Ord. When Clinton Defense Secretary Leslie "Les" Aspin slated Fort Ord for closure, and handed it to the US Department of Education—the dream became a reality. Without privy to the inner workings of Congress, the White House, or the California State House the school's underpinnings were shrouded in mystery. In Washington, DC, President Bill Clinton, "determined that Fort Ord would become a model base conversion: the 21st California State University campus for the 21st Century." The USDE handed Fort Ord to the California Postsecondary Education Commission, CPEC—CPEC, in turn handed-off to CSU Chancellor Barry Munoz. After the catastrophic failure of Hillary-Care, Hillary Clinton sought to rehabilitate herself politically. Bill Clinton proclaimed himself America's Education President. Under the guise of a San Jose State extension campus, Barry Munoz handed the venue for personal prerequisite, the epicenter of diversity and multiculturalism over to the Clintons & the Panettas.

The White House launched the Presidential Search Committee and tapped former Vermont Lieutenant Governor, congressman, state senator, (then) George Washington University Dean, School of Human Education and Development Dr. Peter P. Smith. President Smith's second order of business: hold out CSU Monterey Bay to the public and prospective students, as a comprehensive California State University. While a past master of the half-day seminar, Smith never lets on that neither he, nor Leon Panetta have any provision for graduating the innocent, the eager, and the doomed—but initiates a confidence game instead. Both masters of the double-cross know the system to help juniors, or those with 4/5 of their General Education course work completed, finish requirements, and graduate within two years is nonexistent. Simply put, a classic case of fraud in the inducement.

In 1993, Bill Clinton appointed Congressman Panetta director of the Office of Management and Budget. (Aspin had had problems securing the fort.) In 1994, Clinton appointed Director Panetta, White House chief of staff. By 1995, Chief Panetta launched an aggressive recruitment campaign at the level of press, radio, and TV. Panetta faced competition for freshmen and sophomore admissions from the area Junior Colleges: Cabrillo College, Hartnell College, and Monterey Pacific College. The University of California SC, dismissed California State University – Monterey Bay, as "Taco Tech" and "Artichoke U." Nevertheless, Panetta roped the 404 transfers with lower division coursework, whose numbers he vetted at the pre-Registration Seminar, plus the 161 freshmen. As alluded to in the title of Panetta's 1992 Congressional Report, his mission: Restore America's Future, Prepare the Nation for the 21st Century. "One of the new arrivals," writes Leon Panetta, "would come from Vermont by way of Washington, DC, and George Washington University. Peter Smith, the founding President of CSUMB, embodied the real-time experience of an educational pioneer, the political saavy [sic] of a former Congressman and the passionate belief that learning ought to be at the center of a university."

"The faculty," continues Panetta, "had not expected to teach for a full year and a half after their arrival." Even though the faculty argued for admission at only one or two levels, the politicians admitted 565 students at all four levels. The faculty could handle freshmen admissions at best. The pre-Registration Seminar had been a deliberate ruse. To coincide with their graduation date, President Smith also told the 404 upperclassmen that accreditation would take place by 1997. Peter P. Smith held out this incentive with no reasonable basis for believing it to be true; and it was, in fact false. Students were ignorant of the falsity of Smith's representations, and believed them to be true. In law this is a deliberate crime. Peter P. Smith writes: "With rare exception the organizational growing pains of CSUMB did little to dampen the spirit, tenacity, and enthusiasm of those readying the 'experiment' for students." As if taken aback by the recklessness of his own disregard, with easy conviviality Peter P. Smith chalks off enrolling students: "Our single worst decision."

Monday, 04 September, Bill Clinton dedicated the 21st CSU campus. In the college catalog Peter P. Smith, notes: "number of community members who attended the Dedication Ceremony with President Clinton Labor Day, 1995: 23,000." As the

community members" arrived by motor vehicle, the right lane of Highway No.1 South backed-up at **Fort Ord's main gate** for several miles. The "community members" must have been **from out of town**, because **none continued to Casa Verde Street** and used the underpass to proceed on Highway No.1 North to Fort Ord, but all waited in a long line of traffic. The quadrangle, an open space of **gray windswept earth**, partly enclosed by **Fort Ord's main buildings** had been **cordoned off** with metal detectors. **The standing room only crowd** now awaited the 42nd President of the United States. The wait was **punctuated by glimpses of the African Americans** present that day: **snipers as they scurried about the rooftops**. Security was tight. At high noon, President Clinton addressed **the beleaguered, sunburned "community members"** packed together under the noonday sun; the sardines had returned to Monterey.

It was Labor Day. Amid **sparse applause** President Clinton **threatened to raise the minimum wage**. Bill Clinton talked about the public sector, and the private sector, but labeled the **nonprofit sector—"a political gold mine."** The CSU: nonprofit. **That is, non-taxpaying.** Clinton characterized Panetta as, **"Pushing like a demon for 'UCMUB."** (although the University of California & The California State University are separate systems, the Governor and the Legislature recognize **the transfer** as a central institutional priority, and call for students who have obtained eligibility as either a freshman or a transfer student—a **guaranteed place** within either **UC or CSU**.) Chancellor Munoz says he favored the name **UNIVERSITY of FORT ORD**, with its wieldier acronym, **UFO**. CSUMB's christeners, to date, **remain anonymous**. In those **halcyon days**, Leon Panetta had all but announced his candidacy for governor. Gray Davis (D) would succeed Pete Wilson (R) as governor. But before Davis's recall for **blatant corruption**, which Panetta decried—"I think it's a terrible precedent ... **bad for California, bad for our economy, and very frankly ... bad for our politics**"—he also added his own name to the list of gubernatorial hopefuls. Words like **multiculturalism & diversity** had yet to mar the lexicon. **With protruding lower lip and raised thumb, Bill Clinton dubbed Leon Panetta: patron saint.** Bill Clinton promised the pioneers a **21st Century education**. Behind the man behind the podium, White House Chief of Staff Leon Panetta (D), current 17- District Congressman Sam Farr (D), State Assemblyman Fred Keely (D), and Dr. Peter P. Smith (\$) all **exchange toothy grins**.

Before Bill Clinton concluded the dedication speech, Peter P. Smith says **he not only knew who will graduate** from CSUMB; **he also knows when they will graduate**. Smith's predictions were based **not on scholastic merit or even ESP**, but something far more reliable: **the Clintons Politically Correct agenda, gender & ethnicity**. **Given Peter P. Smith's physic ability**—it is reasonable to believe that **Smith also knew who will fail to graduate**—and indeed he did. Smith knew that **except for his hand picked minority students—graduation by Spring 1997** was a complete fabrication. **A total sham. As chief executor of the CSUMB FOUNDATION FUND**, into which all student rents, tuition & fees accrued, Peter P. Smith did **willfully and deliberately deceive and defraud students**. And, for his own aggrandizement. Peter P. Smith's **deliberate deception, dishonesty, and double-dealing—duped and defrauded students**, their families, **college loan providers**, including the federal government. **In the annals of fraud**, CSU Monterey Bay can be likened only to a **publicly funded ENRON**, with Dee Dee Myers on the board of directors.

When Bill Clinton **appointed Margaret J. "Dee Dee" Myers** White House press secretary, Dee Dee lived in Leon Panetta's 17th District **beach town of Aptos, Calif.** **Despite the fourteen-year age discrepancy**, Dee Dee was billed an **"old school chum"** of Hillay's. Myers and Panetta's age difference: twenty-three years, but both attended **Santa Clara University**. Shortly before CSUMB's dedication, **young Dee Dee** got **arrested for drunk driving** in Washington, DC,—while driving the wrong way on a **one-way street**. Before his recall for **corruption**, Governor Gray Davis appointed Dee Dee **The California State University's 23rd Trustee**. Dee Dee and the twenty-two other like trustees also **approve honorary degrees, and the three annual raises**

for **The CSU's faculty** and its twenty-three presidents. Bill Clinton appointed Leon Panetta White House chief of staff, *the Presidential Search Committee* drafted Peter P. Smith to head **the 21st CSU Campus**, and before **the 1996 presidential election**, the Education President wanted undergraduate students, and or flight students.

With a green light from Capitol Hill, the "new innovative university" **opened its doors**. That same year, Hillary Clinton, would **arrive in China** to make **her debut on the world stage**. Blissfully unaware, according to her, **Monica Lewinsky** had **arrived at the White House**. In December 2007, Ms. Clinton would summarize the visit. "You know, 12 years ago, I went to China, and **the Chinese didn't want me to come**. And **they didn't want me to make a speech**, and when I made the speech, **they blocked it out from being heard within China**, where I stood up for **human rights** and in particular **women's rights**." (The Chinese issued a rejoinder stating that, the first lady's teaching on the female orgasm was tasteless.) That year, Bill Clinton would also **formalize the invasion plan for Iraq**. And although the **"inappropriate relationship"** between **president and intern** which began November 1995, would lead to **Monica being subpoenaed in the Paula Jones case** (Bill's **prior misdeeds at the Excelsior Hotel**), Bill Clinton's own coming out—in Leon Panetta's office, **atop the chief of staff's desk**—wouldn't be made public until January 1998. Currently, **"The Office of President Clinton**, based in New York City, offers students with a **passionate interest in crucial issues** of today **the opportunity to contribute** to the work, **vision, and goals of President Clinton**. Internships are offered throughout the year in the following areas: communications, correspondence, domestic policy, **foreign policy, operations**, and scheduling and advance. Applicants must be undergraduate juniors or seniors, recent college graduates, or graduate/professional students."

THE COUNTDOWN TO 9-11

FORT ORD TAKES ITS NAME FOR General Edward Otho Cresap Ord, whose military career spanned 1839 to 1881. Gen. E. O. C. Ord acquired for \$40 the marble topped table, present when Confederate Gen. Robert E. Lee met with Gen. U. S. Grant **at Appomattox Court House**. **The small wooden table**, not to be confused with Gen. Ord's table, went to Gen. Sheridan for \$20, who gave it to "boy wonder" Gen. George Armstrong Custer. Today, that table rests in **the National Museum of American History**, Washington, DC. Whereas **the marble topped table** resides in **the Chicago Historical Society's Civil War Room**. Controversy over which table sat Grant, and which sat Lee continues—but it is certain **one of the signatures to the surrender terms was signed on Gen. Ord's table**. (No word as yet on the disposition of the desk upon which Bill Clinton signed away his political career.) Leon Panetta however, has offices and **archives his congressional record on Fort Ord**. He received **\$1,400 per day, as an educational consultant, \$350,000** more from incoming **Chancellor Charles B. Reed**, for startup costs and salaries for the **Panetta Institute for Public Policy**, plus **\$50,000** in "materials" from Peter P. Smith. According to **the Otter Realm**, CSUMB's fledgling newspaper (**sea otter**: school mascot), the Panetta Institute also sought a **permanent endowment of \$10 million-dollars**. Panetta to *Otter Realm*, **"It is important for people to feel the reward of service."**

It's a rare occasion when the president dedicates **a college**, but for most in attendance Bill Clinton was audible only via loudspeaker. Far from **the prying eyes of inquisitive, gossipy Washington, DC**,—CSU Monterey Bay's lineage would **go undetected**. Fort Ord closed due to **the end of the Cold War**—end of story. As Bill Clinton boarded **Air Force One**, bound for **the White House** and his date with destiny, the "community members" were left to wend their way home. **Elvis had left the building**. Besides **his own political apparatus**, Leon Panetta, now had **a cadre of FOBs** (Friend Of Bill's) aboard. Unbeknownst to students, the Clinton White House would be ever-present. In 2004, Peter P. Smith published ***The QUIET CRISES: How Higher Education Is Failing America***. Smith, *"an individual uniquely qualified to make such judgments,"* declares **Hillary Clinton's "experiment," is the answer**. Smith begins his **magnum opus**: "I work at California State University (CSU), the largest university in America. It serves a state so **economically large and diverse** that were California an independent nation, its gross national product would be **the fifth largest in the world**. **The university itself educates more students in a year** than attended all American colleges and universities in 1900—now **more than 400,000** full-and part-time students every year."

Smith awarded Bachelor's of Arts Degrees to not 152 students, but only 06 minority students, and 01 Caucasian valedictorian to enunciate the farewell address.

In a cameo interview, Leon Panetta says: "It was clear from the time that I served the president as director of the Office of Management and Budget, which was before I became chief of staff, that he had a great interest in making sure his legacy would benefit the American people and be one that would last in history." If Peter P. Smith possessed the passionate belief that learning ought to be at the center of a university, Leon Panetta possessed the passionate belief that money ought to be at the center of a university. Before leaving office, the Education President raised the ceiling on student loans, and effected monumental increases in Federal-funding for schools with a 28 percent Hispanic enrollment. CSUMB: Hispanic, 28 percent. In May 1997, CSUMB held its first commencement. Amid the festive atmosphere of a hastily erected carnival tent—in the parking lot of the freshly stocked Oppression Studies Library, adjacent the quad where the 42nd President promised the pioneers a 21st Century education—UNIVERSITY of VIRGINIA President John T. Casteen, delivered the keynote speech entitled *America's Oldest University Addresses America's Youngest University*. Arguably, the College of William & Mary boasts that distinction, but Peter P. Smith even cozened the remaining 145 Seniors to "walk through" at the media-staged event, receive an empty, irredeemable diploma folder and a fleshy handshake from St. Panetta.

Leon Panetta began his political career with the Republican National Committee, but switched to the Democratic National Committee, because he felt the DNC had a "larger tent." Panetta gives the Seniors who stayed the course, short shrift—but recounted the White House incident, in which a small plane crash-landed on the East Lawn during the predawn hours. Leon Panetta asked his startled staff, presumably by telephone, "Has anybody done anything yet?" Panetta pounded the podium. His message to the gowned captives under the rent-a-tent: "Get it done." Why Leon Panetta felt that his staff should handle the situation, instead of say the Secret Service, is in and of itself a whole other can of worms. (March 2005, a trench coat clad Panetta, then co-chair of the Governor's Base Support and Retention Council would emerge from the confines of the Panetta Institute on Fox

TV News, to finally take credit for the Fort Ord closure.) Although UFO lacked both a Master's program and a Doctoral program, before leaving the big-top to confer upon himself an honorary PhD, at the separate but equal La Raza (The Race) graduation ceremony, the eloquent Panetta shouted to the crowd: "Bill Clinton has so few problems as president, because—his chief of staff is Sicilian!"

PART II

THE UNIVERSITY OF BILL CLINTON: *Home of the Al Qaeda Air Force*

AS THE SURF ROARED ALONG THE MONTEREY COAST AND UP THE CLIFFS

Peter P. Smith made log entries for his secretary, Brenda First, to transcribe into an electronic document. **Smith's official record** entitled, *Awakenings and Beginnings: Introduction*, would serve to carry out his **first order of business**: keep the White House advised. In Chapter 1, Smith begins his first electronically recorded paragraph:

"Standing at the flagpole up the hill from the grass-covered center of the main campus, a visitor sees an array of colorful, landscaped buildings and the steady flow of people moving from class to class, meeting to meeting, or to a host of other activities that constitute a typical day at California State University Monterey Bay. This is but one of many simple scenes that represent a six-year conversion and transformation process that began in 1991 when the citizens of the Monterey Peninsula and the California State University faced both the challenge and the opportunity of converting a military base into a comprehensive public institution of higher education. This is a story of risk, courage, commitment and change. The cast of characters represents a community privileged by the unique opportunity to transform higher education for the 21st century. Pioneers all, each has made a contribution and each continues to make history."

When Smith penned *Awakenings and Beginnings* at the close of CSU Monterey Bay's "inaugural year," due to the infancy of the electronic medium the primary recipients of such missives would be universities, government agencies, and the military. **Chapter 1** however, had been crafted for **1600 Pennsylvania Avenue**. More specifically, **the Oval Office**. Peter P. Smith's second paragraph speaks volumes:

"During the early summer there was a reorganization of Residential and Dining Services that afforded the Director of Housing the opportunity to take a one-year staff development leave. Preparations and planning for year two were well under way as the summer unfolded. The Fort Ord Alumni Association, a group of former Fort Ord military personnel, is established by the Office for Institutional Advancement and becomes the largest alumni association in the world. **The University provided housing and dining services for its first group of foreign students from the United Arab Emirates. They paid for the rehabilitation of the housing facilities they inhabited and used a nearby airport during a six-week flight training course. Members of the campus community questioned their presence as a viable, educational endeavor. Cultures clashed when the group of 15-19 year old males encountered the female students employed at the dining commons. The venture will eventually succeed and a new group of students will return during the summer of 1997** (emphasis mine)."

Peter P. Smith's document was akin to discovering **the Rosetta Stone**. Without it, **the seeming chaos that characterized CSUMB** might have gone undecipherable. In it, Smith says members of **the campus community** questioned the presence of flight students as a **viable, educational endeavor**. Smith knew the dust-up in the

students as a viable, educational endeavor. Smith knew the **gossip in the cafeteria** would give his detractors, **disgruntled Hispanic faculty members** who felt sponsoring Middle Eastern "students" ran counter to CSU Monterey Bay's *unique Vision Statement*, ammunition with which to **foment campus unrest**. Despite the fact that Hispanics, not Middle Easterners were **Smith's target enrollment—teenage Arab airline pilots** were as yet an unknown—Smith advises **the White House** on the progress of the "venture." Alerts **the Clinton's opposition research**. As for **plausible denial**, Smith **believed his server was secure**. But at the height of the bipartisan 9/11 Commission investigation, **after receiving a copy** of Smith's document(s) from a **well-intentioned source**—Sandy Berger realized that **further evidence** of the Clinton, Al Qaeda connection existed in the form of *Awakenings and Beginnings*, which **he promptly stole from the National Archives**, and shredded with a pair of scissors.

Smith describes for his benefactors **an array of landscaped buildings** and the steady flow of people on the now **grass-covered quad**. People moving from class to class, or **other activities**. And although Smith's narrative spans 1991 to 1996, the Clintons, the Panettas, even wife Sally who gave Fort Ord a **heinous Day-Glow makeover**, the **privileged community** who "**transform higher education**" for the 21st Century—the history-making pioneers—all remain anonymous citizens of obscure origin. Nameless, faceless people, **on a bucolic day at a generic college**. The Fort Ord Alumni Association; **world's largest alumni association**: unnamed military personnel. Smith also reports this **seemingly insignificant incident**. "During the early summer there was a **reorganization** that afforded the **Director of Housing** the opportunity to **take a one-year staff development leave**." But **the stark admission**: "The University provided housing and dining services for **its first group of foreign students from the United Arab Emirates**. They paid for the **rehabilitation of the housing facilities** they inhabited and used a nearby airport during a **six-week flight training course**"—ought to dispel any ambiguity about Peter P. Smith, or that "cast of characters" in **Congress**, the **White House**, and the **California State House**.

In addition to the **\$1 billion-dollar parcel** on Fort Ord, and **several tracts of military housing**, purchased from the **Department of Defense for \$1-dollar**, CSUMB also received a **\$25 million-dollar startup allocation**. Leon Panetta asked Congress for an **additional \$100 million-dollars** as a "lump sum," but settled for **\$10 million-dollars per year for ten years** instead. After his experience with an **Arkansas Air Force base**, Bill Clinton says **he vowed to bankroll** the California conversion. Peter P. Smith reports, "**Another round of federally allocated EDA** [Economic Development Administration] funds for the renovation and build-out of campus facilities was anticipated. **Before it was in hand, the \$14 million would be held hostage** to the **discrimination complaints of local minority contractors**. By Fall 1996, the issues would be mediated and **the funds would be released**." Meanwhile, Leon Panetta "**silenced**" the Fort Ord Reuse Authority (**FORA**), used the Base Realignment And Closure Commission (**BRAC**), beat out the University of California (**UC**), and **dashed all hope of a San Jose State extension campus on Fort Ord**. With San Jose State still performing the **accounting function** however—when **Al Qaeda paid upward of \$70,000 for the housing**, Smith lacked legitimate provision to **accept the orphaned cash**. So, **Housing Director Ms. Mary Ellen Ashley** pocketed it.

In the absence of the military, **the Central Coast climate incubated flea and vermin populations to epidemic proportion**. Profuse accumulations of waste and decay from the **small stealthy rodents**, and the **leaping blood-sucking insects**, had **sun-baked into every nook and cranny** of the ex-Army dwellings. Although the **initial 1,253 units, already bought and paid for by the taxpayer**, at another point in time, would provide their Leftist landlords with a **generous income in perpetuity**—the mere act of opening a cabinet or drawer would **reinvigorate the sickly sweet aroma**. The campus would be loaded with the latest in **high-technology teaching tools**; but not for long. While Peter P. Smith **wandered the forlorn cluster of adobe style buildings** that passed for main campus, **glad-handing and regaling** all in sight—it **was time for a heist**. The latest in teaching tools arrived. But during a **daring daylight robbery, with all the earmarks of an inside job**—disappeared just as quickly. Peter P. Smith **cheerfully** shelled out the **\$100,000 dollar deductible**. Campus Police investigated, but neither the hijackers nor the computers have yet to surface. San witnesses it would be as if **the ill-fated Apple computers** had never

surface. Can wireless, it would be as if the imitated Apple computers had never even arrived. **CIGNA** dropped CSUMB like a hot turd. Augmenting the 21st CSU campus's **pervasive potpourri of poisonous wastes**, excrement, infestations, and larcenies were its marinated, sautéed, and cooked books. **And, situated just upwind loomed** the Nation's third-largest **Super Fund dumpsite**. A 500-acre century-long **accumulation of US Army refuge**. Another incidental **21st Century architects**, Dr. Leon Panetta, and Dr. Peter P. Smith decline to mention.

THROUGH HIS ASSURED ACCESS PROGRAM, Peter P. Smith required students to purchase an Apple computer. Smith's estimated cost per student: \$2,500 to \$3,500. Students would purchase the computers through Peter P. Smith's vendors. For about \$3,000, students also got CSUMB's **problematic server**, **Netscape Navigator 1.1**, and the communication system **First-Class Client**. A campus email system was born. According to *Newsweek*—"When California State University **administrators drew up plans** for their newest campus ... **one building was conspicuously absent** from their blueprints: **the library**. But as Barry Munoz, Chancellor of the 22-campus system, sees it, **why bother** wasting all that money on bricks and mortar and expensive tomes when **it could be better spent on technology** for getting information via computer? **You simply don't have to build a traditional library these days**, Munoz says."

In 1995, Chancellor Munoz was **apparently unacquainted with copyrighted print materials** (books). **Conservative estimates** put bona fide on-line libraries somewhere around 2015. Peter P. Smith expected students to purchase the high-tech teaching tools in order to **complete the research and assignments needed to graduate**; and create an on-line community. Were Munoz, Panetta, and Smith **ahead of their time, or plain stupid**? What's certain, is that **the architects defrayed nary a dime** to bricks and mortar—but **brokered the technology** for getting **scholarly information, they said existed** instead. Indeed, **why waste all that money**? So, it was a **surprise** when midway through the first semester, **a situation arose that would put the on-line campus community to the test**.



The barriers between academic disciplines have broken down;

A student email alerting campus residents to ongoing home invasion robberies had been posted. **Intruders entered** into several campus dwellings, **while shocked and stricken residents were present**. Descriptions of the non-resident individuals, and **locations of the incidents** were provided. **As the mid-afternoon crime spree wore on**, CSUMB's official response, or lack thereof was telling. The on-line community reported; *First-Class Client* worked. It was President Smith's reply: **nada**—that was incongruent. After all **the money**, all **the trouble**, and all **the hype**—when push came to shove—**the result was anticlimactic**. In the absence of any alert by Campus Police, Peter P. Smith might have at least countered: **RUN FOR YOUR LIVES**.

College presidents trump campus chiefs of police on policy issues; still and all, a **heads-up** from either official might have averted tragedy. Due to an initial **crisis of**

confidence” though, Peter P. Smith suffered a **rather large student attrition rate**. While anything but common knowledge, **confidence man Smith** had been appointed by the Clintons and, **not for sterling ethical conduct**. Peter P. Smith had already **burned down a banking career**, a short-lived elected office or two, and a **stint as college dean**. As political appointee, Smith had **ardently misrepresented CSUMB’s clouded curriculum and environmental hazards**. It was a make or break situation, compounded by **an upcoming presidential election**. Under the circumstances, Peter P. Smith did what any red-blooded college president would do—he sat on his thumb.

Initial discussion centered on creating a **San Jose State University satellite campus**, which would replace and expand the San Jose Center in Salinas—but in 1991, **The CSU Board of Trustees named Barry Munoz Chancellor of the largest higher educational system in the world**. “Invested with the **power and authority to make dramatic changes through restructuring, experimentation and innovation**, Munoz saw the potential of the new campus for **building models for change**,” says Leon Panetta. **Moreover, the potential to change Fort Ord into Panetta’s own campus wasn’t lost on Munoz. Munoz was subsequently awarded**, as chief executive officer of the **J. Paul Getty Trust**, an unbridled eight-year romp through Getty’s assets.

Before being reabsorbed by The CSU as a highly paid “Trustee Professor,” it appears doubtful Munoz gave **on-line libraries** a second thought. What with his million dollar-plus salary, **Porsche Cayenne loaded to the gunnells with pirated Italian antiques**, overseas travel, five-star hotels, **questionable real estate deals**—the \$8.6 billion dollar trust also suffered **over \$1 billion** in stock market losses. Under **multiple investigations**, Munoz resigned from Getty in 2006—**received no severance package, but paid the Trust \$250,000** to resolve any continuing disputes. At least Chancellor Barry Munoz had had a sense of humor: **on-line libraries**, such a kiddie.

In 1999, **Getty Images purchased Art.com**. Getty maintained a **digital archive** of over 70,000 images. Art.com sold posters online—did printing, framing and shipping, all on demand—**no inventory**. Art.com’s **domain name alone cost \$400,000**. Getty Images still managed to snatch defeat out of the jaws of victory by dumping Art.com, which was **snatched up** the following month by a computer savvy competitor.

THE CASE AGAINST PETER P. SMITH, et al.

World domination. The same old dream. Our asylums are full of people who think they’re Napoleon. Or God. —James Bond, *Dr. No*

I REMEMBER HIM AS IF IT WERE YESTERDAY, WILLIAM JEFFERSON CLINTON: code-named “Elvis” by the Secret Service. Elvis’s next public appearances on the **Central Coast** would be a **1996 Pebble Beach golf outing**, and again for a **2003 speaking engagement at the Leon Panetta Lecture Series**, sponsored by the **Panetta Institute—paid for by CSUMB, i.e., the taxpayer**. Enter, **Warren Minor Christopher**. In 1992, Warren M. Christopher headed the vice presidential search for (then) Governor Bill Clinton. During Clinton’s first term, Christopher served as **Secretary of State**. Warren Christopher also served as **Director and Vice Chairman of the Council on Foreign Relations** (Google this guy). **At Georgetown University**, Bill Clinton’s professor **Dr. Carroll Quigley**, stated in his highly regarded course, **Development of Civilization: “The Council on Foreign Relations—established 29 July 1921, in New York—is the American Branch of a society which originated in England, and believes national boundaries should be obliterated and one-world rule established.”** Christopher even served as a former Chair of the **California Postsecondary Education Commission, CPEC—CPEC, that same state agency to which Fort Ord was ceded by the USDE**. Gorelick is a **member** of the Council on Foreign Relations, as is **Lee H. Hamilton**, **Sandy Berger**, **Madeleine Albright**, **Peter P. Smith**, and **the late Leslie "Les" Aspen**. **Lee Hamilton and Leon Panetta** co-chaired the "bipartisan" **Baker-Hamilton Commission or Iraq Study Group**. Lee Hamilton is also a **member of the Trilateral Commission**, as is **Warren Christopher**, and **Leon Panetta**—while **Sandy Berger** is a **regular Bilderberger**. No pun intended. Suffice it to say, both **the Bilderberg Group** and **the Trilateral Commission**, founded respectively in 1954, and in 1973, are **secretive organizations**, bent on a one world government. "They will rule the future."

In a related matter, in 1982 when **Vermont Judge Edward Cashman** was appointed to the bench, **Peter Plympton Smith** was a **state senator**. His younger brother **Charles Plympton Smith IV**, was **staff director and administrative assistant** to **James Jeffords**. Although **Charlie P. Smith** had taken to telling "flatlanders" he

When **Howard Dean** said, "A lot of Republicans have **never earned an honest living** in their lives," he was talking about **Hillary Clinton's higher education guru**. "Landlords are only responsible for providing the water supply. **They are not responsible** for the quality of the water unless: 1.) The landlord owns the well or **other water source** that supplies water. 2.) There is a physical problem with the **plumbing system** that causes **water contamination**. The city or other public agency is responsible for assuring the healthfulness of the water supply," **spouted the ex-congressmen**. "ABOUT THREE O'CLOCK ON SATURDAY MORNING, SALLY AND I were awakened by a **loud thump,**" writes Peter P. Smith, "from the front of our house. **It was pitch dark**. I ran to **our front door** and confronted a **group of young men vandalizing our house**. Sally's **car tires were slashed** and her **car was scratched** seriously in several places, **ruining the paint job**. There were **eggs and paint balls covering the house and the cars**. It will cost **hundreds of dollars** to repair the damage. But there is more to it than that. **People in the night, attacking our house**. **They had been sneaking around** our house **in the middle of the night**. There was a **knife**. Did they want to **hurt our animals**? Us? Were they trying to get into the house? **Two doors were open** when I came downstairs. **It was frightening**. I went after them, chasing a young man across the grassy area in front of our house. I couldn't catch him before **he jumped in a car** and took off. I couldn't get the number as they disappeared around the corner. So, I returned home to **property damage** and a huge mess.

It was a dangerous situation. Someone could have been **badly hurt**. This **attack was anonymous, and hateful**. **Sally and I were attacked** because of who we are and **someone's twisted opinion** about what we have or have not done. As **individuals and as a community we must condemn and resist this kind of dangerous and cowardly attack** whether it is **on someone's reputation, their person, or their property**. I have spoken with members of the Cabinet and they are **united in their condemnation**. I think Bert Rivas said it best when he said, **this must stop**. **It is outrageous** and we must **stand together as a cabinet and a university to fight it**. So, what is 'it' we are fighting? Since last Spring, there has been a **continuing attack** directed at Sally and me by **a few members of this campus community**. The point has been to **make life so unpleasant** for us that we'll leave the university.

That will not succeed. The attacks have **questioned my integrity**, fairness, and professionalism **as well as background**. Some people have even said that the state where I was **born and raised, Vermont**, disqualifies me for the Presidency of CSUMB. **That is nonsense** and most people know it. Some of **the attacks, on email and in public remarks**, have been hateful, others have also been anonymous. And, whenever other people attempted to create a **more civil dialogue** on this or related issues, **they were attacked**, sometimes publicly for their opinions. I connect this **climate of anonymity and hatred** to the attack on our house. **Hateful speech leads to hateful actions**. We have only to look to **the nation's abortion clinic murders** [what was he doing in there?] to know this. And hiding your identity is **the staple of terror; the way the Ku Klux Klan hides behind their hoods** to avoid identification. **We must live by our policies and the laws of the land**. I will continue to do that. To those **peddling these attack messages** and those who attacked our house, I have one message: stop, now."

Smith chased a few members of the campus community; "I couldn't get the [license] number as they disappeared around the corner." "This attack was **anonymous and hateful**," says Smith. But **Smith knew full well he wasn't chasing Nordic females across his yard at 03:00 am**. He knew **the getaway car wasn't a SAAB 900**, nor had any **runic symbol been painted on his house**. Peter P. Smith knew why members of the **campus community vandalized his property**. And he knew **who did it**. Smith was outraged. "As individuals and as a community we must condemn and resist this kind of **dangerous and cowardly attack** whether it is on someone's reputation, their person, or their property," intoned Peter P. Smith. **When the attacks were on others, Vermont's traveling scholar had turned a blind eye**. Now the dangerous and cowardly attacks **were on his turf, making his life miserable**. When Smith's **property and veracity** were on the line—"it," was a call to arms.

"So, what is 'it' we are fighting?" Smith *knew* "it" was the (National) Movimiento Estudiantil Chicano de Aztlán. "It" was **M.E.Ch.A.**: an organization equivalent to that of a **brown skinhead group**. Mechistas strongly **believe in racial separation**. Motto: ***For the race everything – for the outsider nothing***. In their zeal to include M.E.Ch.A. **under the progressive banner**, the Clintons, the Panettas, and the Smiths gave M.E.Ch.A. *carte blanche*. M.E.Ch.A.'s stated goal: **overthrow of the US Government, by any means necessary**. **M.E.Ch.A. adheres to the aims of La Raza**. At CSU Monterey Bay—M.E.Ch.A.'s **specific objective: follow the concepts laid out in EL PLAN DE SANTA BARBARA**. Prime Directive of **EL PLAN DE SANTA BARBARA: Use anything or anyone capable of furthering the goals of La Raza**.

Smith might have upheld their oaths—but **why bother?** Teaching and promoting activity that advocates **the overthrow of the US Government** in the name of multiculturalism: **at the very least, un-American**. Peter P. Smith **posed on the**

quad for a photograph with the school's M.E.Ch.A. chapter, who proudly display the green & red AZTLAN flag. Tierra Y Libertad. Smith would use the color photo, in a full-page community outreach mailer. Peter P. Smith front-and-center, smiles and waves for the camera alongside Mechista faculty, students & staff. Viva Zapata!

Peter P. Smith sums up the 2001-2002 academic year: "The campus community celebrates the reopening of the Black Box Cabaret, hails the opening of the Campus Center, breaks ground on its first-ever new building. But early in the year, the notorious demise of an integral piece of the New York skyline reminds us all that buildings can be as precious—and as destructive—as the people they are created to embrace." Nonetheless, New York Senator Hillary Clinton attends none of the funerals for the 9-11 victims. Bill Clinton himself downplayed the 1993 attack on the World Trade Center. He declined to visit the site of the attack. Bill Clinton was in Australia on 9-11; Hillary Clinton, in Washington, DC. Leon Panetta was in Washington, DC, on 9-12 and had planned to fly back to Monterey that evening. But with the nation's airports shut down, he was stuck. "I'm seriously considering a rental car," Panetta told the Santa Cruz Sentinel before explaining away the 9-11 attacks, as having been "unforeseeable." (Australia has a 91-page extradition policy.) By May 2005, M.E.Ch.A., as part of *Semana de la Raza—The Week of the Race*—a week-long celebration of Chicano issues and "multiculturalism," sponsored University of Colorado Ward Churchill's speech. Four years to the day into Dell Felder's extended hiatus, Bill Clinton told **David Letterman on The Late Show**, "I just came back from **visiting a friend in the Middle East** who presided over the **graduation ceremony** of a new university." As it turns out, Dr. B. Dell was an **FOB**. University: **ZAYED UNIVERSITY, UAE**. Clinton went on to say he was pleased with **multiculturalism**, but believed **an integrated global economy and multiculturalism** needed a few more years. Although **Al Qaeda** was **believed responsible for the blasts**—in response to which Bill Clinton **ordered cruise missile strikes**, but announced the **planned strike in a prime-time TV address**—before Clinton could answer, **across his face there flashed** nothing less than "a meaningless facial tick."

Set the Wayback Machine for 1991. On a warm afternoon at **San Jose State University**, Bill Clinton running against Texan George H.W. Bush, and Texan H. Ross Perot tells California's **higher education community**, the **Cold War Peace Dividend** should be used to **beat swords into plowshares**. To recap: In order to **pirate the Peace Dividend**, the Clintons must **setup a front—a college**. In 1993, Bill Clinton appointed **Congressman Leon Panetta**, OMB Director. Panetta puts **Fort Ord on the block**. Clinton Defense Secretary **Leslie "Les" Aspin** possessed the **academic bona fides** to head a **California State University**, but **Aspin fails the test in Somalia**. Mired in the 1993 **Battle Of Mogadishu** controversy, and possessed of **dubious political capital**, Les Aspin would **draw negative attention** from the Army. Aspin failed to honor **General Colin Powell's requests for tanks and armored personnel carriers** prior to the battle. **Les Aspin** was slated to head the **new university on Fort Ord**. However, in 1995 Aspin died of a **stroke** at **Georgetown University Medical Center**, while head of Bill Clinton's **Foreign Intelligence Advisory Board**.

In 1993, Congress passed the **Pryor Amendment**. That is, Fort Ord **without use restrictions**. The **Pryor Amendment** even **appropriates money** for the foreseeable legal defenses the **negligent act** is likely to engender. In 1994, **Bill Clinton** appointed **Leon Panetta** **White House chief of staff**. *The Presidential Search Committee* **picked Vermont charlatan Peter P. Smith**. Smith. says he was **"inspired**

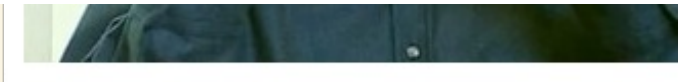

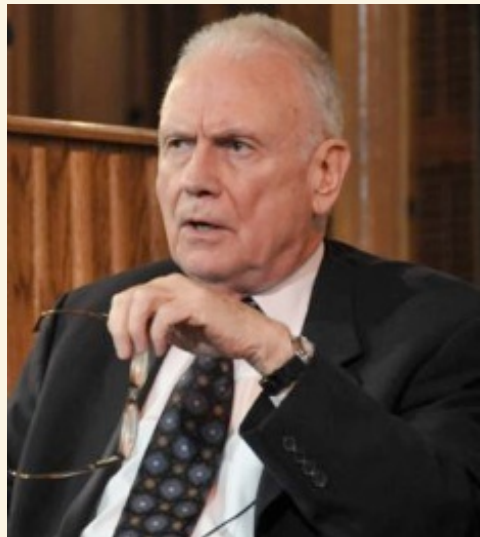
