

La Paz: U.S.-Mexico Regionalism

People can debate when the War of Terror began, but this writer places the date on August 14, 1983 when President Ronald Reagan signed a treaty between the United States and Mexico. It was signed in La Paz, Baja California, Mexico with President Miguel de la Madrid signing for Mexico. The reason for selecting that date as opposed to an earlier time is because the La Paz Treaty was the first actual breach of our borders and it led to an internal bifurcation (international and domestic) within the agencies and departments of government.

The purpose of the treaty was ostensibly border environmental cooperation. It created a geographically defined international zone 100 kilometers on either side of the inland border and maritime boundaries between Mexico and the U.S. The full map can be seen [HERE](#).



The La Paz treaty was a framework agreement that marked the end of nation-states in the Americas. The globalist vision of planetary organizational management is management by geographic region - eliminating the culturally based nation-state subdivisions.

In 1987, Reagan signed a bilateral 'Free Trade Agreement' with Canada and then another framework agreement with Mexico both of which began negotiations for the North American Free Trade Agreement (NAFTA) that was signed in 1993 and went into force in 1994.

The net effect of these agreements was to create a Common Market between the three countries though the term 'common market' is studiously avoided. Ultimately the plan was to create a 'Free Trade Area of the Americas' or more accurately, a Union of the Americas, completing the vision of creating a continental "governing region" under a world system of governance.

Just as in Europe, while the European Union was being incrementally built, dissolving the sovereignty of the nation-states, terrorism is the tactic to achieve the goal of the globalists. Obviously, to create the continental Union of the Americas, federal, state and local officials must be "moved" to change laws and to institute programs. Terrorism is the tool to force that movement. Since the objective is elimination of the nation-state, which is treason against the state, this War of Terror includes lies, deception, and murder, mis-direction and covert acts of war against the people of this country.

At the highest levels of the government, they know about and understand the purpose of the War of Terror and they are cooperating with the ultimate purpose as evidenced by the agreements and treaties they've signed.
